### FEES

While we know that financial limitations can be a hindrance to getting the help you need, we do not want this to stop you from stepping into your restoration process. For this matter we have created a suggested sliding fee scale to meet you at your ability to pay. Here are the suggested fees:

Sliding Fee Schedule	60 min.	90 min.
Over \$6K/mo.	\$125/hr.	\$200
\$4K-\$6K	\$100/hr.	\$175
\$3K-\$4K	\$75/hr.	\$125
Below \$3K	\$50/hr.	\$75
